Tender Notice

Sealed tenders are invited from the Municipal Enlisted Contractor for granting license for maintaining Pay and Use Type Community Latrine and collecting charges from the users situated at Surpara Road behind Athpur Market, Ward No : 19, for a period of 2 (Two) Years from 01.11.2017 under the following terms and conditions.

Last date of submission of tender is 04.09.2017 up to 2.00 P.M. and the tenders will be openend on the same date at 3.00 P.M.

Each unit of the "Pay AND USE" type public convenience has separate provisions for male and female users with separate entrances.

- MALE
1. 4 Nos Latrines
 2. 4 Nos Urinals

- FEMALE
1. 3 Nos Latrines
 2. 2 Nos Urinals

Lighting, Exhaust Fan and Water facility available.

TERMS AND CONDITIONS

1. That tender will have to be submitted along with Enlisted Contractor Certificate granted by the Municipal Authority. Tenders without Enlisted Holder shall not be considered. But before submission of the tender, tenderer can enlist his/her name after depositing the charge fixed by the Municipal Authority along with the application from. No further earnest money is required for the enlisted contractor. The said enlisted amount will be treated as security money in case of successful tenderer and will be refunded after the expiry of license and on his quitting profession.
2. That the license will collect the charges from the users as follows:
 - (a) To use the latrine or toilet @ 100 paisa each use.
 - (b) To use the bathroom @ 100 paisa (for 5 minutes).
 - (c) To use the urinal or toilet @ 100 paisa each use.
3. That tenderer must quote the rate of license fee per year.
4. That the successful thenderer will have to deposit the license fee for two years at time for taking possession within stipulated period on the date of intimation of acceptance of his tender or on the date following. Failing which, the enlistment rupees will be forfeited to the Municipal Fund and the acceptance of his tender shall stand canceled.
5. That the license shall be given exclusively in the name of licensee and it shall not be heritable or transferable in any way.
6. That the bill of Electric charge will be paid by the license on demand by the WBSEDCL regularly after collecting the Bill from the Electric Dept. of the Municipality.
7. That the license shall be liable for necessary services to mitigate the minor repairing.




8. That the license shall be responsible for the security of the aforesaid public convenience (properly).
