## Quotation Notice

Sealed tenders are invited from the Municipal Enlisted Contractors for granting license for Municipal Tank (Knatapukur) situated at N.C.Road, kankinara in Ward No.08 for a period of 03 (Three) years from 07.12.2018.

Last date of submission of tender is 05.12.2018 upto 2.00 P.M. and the tender will be opened on the same date at 3.00 P.M.

### Terms and Conditions:

1. That tender will have to be submitted along with Enlisted Contractor Certificate granted by the Municipal Authority. Tenders without Enlisted holder shall not be considered. But before submission of the tender, tenderer can enlist his/her name after depositing the charge fixed by the Municipal Authority along with the application form.
2. License will be granted to the highest tenderer for the Municipal Tank shown below for the period of 03 (Three) years from 07.12.2018 to 06.12.2018 for rearing and treading in fish.
3. Tenderer must quote the rate in figure as well as in words of License Fee per year, which should strictly be followed.
4. The successful tenderer must deposit the amount of the 1<sup>st</sup> year's License Fee immediately after acceptance of the tender, failing which the offer shall be treated cancelled.
5. License Fee of per annum to be paid by the Licensee in advance every year positively.
6. The License shall be exclusively in the name of Licensee and it shall not be heritable or transferrable in any way.
7. The Licensee shall not do any such act which will depreciate value of the tank.
8. If the whole tank or any part of the tank is required for Municipal purpose before the expiry of the period of license, the Licensee shall have to quit profession of tank after removing of fishes from tank at his own cost. Municipality will serve one month's notice for the purpose, if necessary and Licensee will get proportionate remission in payment of license fee.
9. The Licensee will have to execute an Agreement at his own cost within a fortnight from the date of receipt of the draft from this office.
10. The Authority reserves the right to reject the highest or all the tenders without assigning any reason and he is not bound to accept the highest tender also.
11. That further conditions may be imposed as and when necessary for the convenience of the users and also for the Municipality.
12. That breach of any of the conditions stated herein shall constitute good and sufficient causes for revoking or withdrawing the license.
13. Only those contractors who are enlisted are eligible for participating this tender and freshers may participate in this tender after enlisting himself after depositing required fees.
