e-Expression of Interest are invited from bonafide and resourceful experienced persons/company for lease of Three years (From 1.9.2019 to 31.1.2022) of one number eighty packs vessel named 'JALADHARA 36' allotted to Bhatpara Municipality vide G.O No 824/PB/WBTC(WBSTC) dated 22.02.2019 to ply between Jagatdal Ferry Ghat and Chandernagore Rani Ghat as per following terms and conditions by the Executive Officer, Bhatpara Municipality.

Scope of Work including terms & Condition:-

1. The interested person / Company must have at least 3years experience in similar type of job.
2. The interested person / Company must have valid PAN No, GST No, Copy of acknowledgement of latest Income Tax Return & Professional Tax Return and valid license of the boatman and sareng.
3. The lessee have to establish ticket counter at Jagatdal Ferry Ghat in the construction made by the municipality as per G.O No 12-WT(F)/TR/P/3W-1/2017(Pt.-1) dated 25.05.2017 under SOP of the Transport Dept. Govt of W.B. project.
4. The lessee has to strictly follow the SOP of the Transport Dept., Govt of WB.
5. The lessee have to use all life saving articles, life saving equipments. CCTV set up,
6. The minimum lease value for 3years is Rs. 30 Lakhs; after completion of one successful year the lease period have to increase for next year. Though normally highest bid will be accepted but the authority will have the right to consider/reject any bid without assigning any reason.
7. The lessee has to provide adequate staff for maintaining the ghat, public toilet constructed by the municipality and the vessel named 'JALADHARA 36' in good condition.
8. The lessee has to keep one bank guarantee of a Nationalised Bank of Rs. 10 Lakhs. (The draft guarantee as a security deposit of the vessel and municipal properties shall be provided by the municipality.
9. The intending tenderer asked to deposit the earnest money of Rs. 2 Lakhs through the e-procurement portal of the Government of west Bengal <http://wbtenders.gov.in> using his login id & password by :

Select the tender to bid and initiate payment of pre-defined EMD/Tender Fees for that tender by selecting from either of the following payment modes:

- Net Banking (any of the banks listed in the ICICI Bank Payment gateway) in case of payment through ICICI Bank payment gateway;
 - RTGS/NEFT in case of offline payment through bank account in any bank.
10. The lessee have to pay the license fee of the vessel regularly to the transport Dept, Govt of WB. Failing which money will be deducted from earnest money/bank guarantee.

11. The lessee have to pricing the ticket Rs. 7 per person over an age of 03(Three) years at present. After completion of one year the pricing,of the ticket shall be determined by the municipal authority time to time.
12. The lessee has to stricktly followed present laws of Ferry Services and any future amendment made by the transport department.
13. The timing of the ferry service shall be from 5.30 AM to 10.30 PM.
